### COMPETITION

Our North Dakota Shooting Sports Association leadership is comprised of competitive shooters. Many of us are hunters, but all of us are competitive shooters. I invite you all to travel this road. Some of it is uphill, but the view from the top of a hill is often really fine. The effort is good for your heart. ## Volunteers (who and why)

Occasionally those of us who volunteer large amounts of our time step back and consider whether we should continue to do so. Each of us will consider different criteria in order to answer that question. Some volunteers don't realize what they are really volunteering to do until they begin to actually perform the volunteer work. I believe that we all volunteer with the idea that we are somehow going to be rewarded for our volunteer work. Almost every volunteer considers the work that they are performing on a volunteer basis to be important not only to themselves but also to those others who benefit from that volunteer work.

The shooting sports in North Dakota have been very well served by volunteer coaches, volunteer shooting clubs, our North Dakota Shooting Sports Association Board of Directors and members and our match directors. I believe that each of us who volunteer to serve the shooting sports in North Dakota in some manner recognize the value of competition and the development of marksmanship skills.

I sometimes wonder though whether the beneficiaries of our volunteer efforts realize that they play a substantial role in the volunteer's continued efforts on their behalf.

About 40 years ago or more Robert A. Heinlein coined the phrase: "There ain't no such thing as a free lunch". Those who benefit from the volunteer's efforts on their behalf need only make their best effort to improve their skills in marksmanship. Our volunteer coaches, match directors, clubs and Association members are all fed very well by the best efforts of our North Dakota competitors to improve their skills in the shooting sports.

On the other hand, the volunteers will starve, if at least a large portion of those people who are competitors in the shooting sports in North Dakota do not pursue the shooting sports with a passion for excellence. So long as those competitors, young and old, enjoy themselves and make a reasonably passionate effort to excel, those who volunteer will gladly give their time and advice to further those competitors' efforts at excellence.

The success of the shooting program obviously depends on the skills of the coach and the passionate effort of the programs' students to develop the skills of marksmanship. The coach must not only be skillful. The coach must devote sufficient time to the program both while his students are present and while they are not. The duties of the coach go far beyond the actual time spent at the range with students. Those who are coaches know how much time they devote to their programs, and it is often three or four times as much time as they spend in front of their students. The coach gives up time that he would otherwise spend with his family in order to benefit his students. In fact, the coach often takes time from work without pay in order to further advance his students' skills.

The coach does all of this without any expectation of monetary reward. Our match directors, club and Association officers and members receive no monetary compensation either. Again though, they are sufficiently rewarded, when students of the skills of marksmanship pursue the development of those skills passionately. The student/competitor is equally well rewarded or fed by the passionate efforts of our volunteers.

I have been volunteering my time to the benefit of the North Dakota shooting sports competitors since about 1975. I am not sure that I can even remember the majority of those individual volunteer efforts I've made to the benefit of the shooting sports over the last 35 years. The hours that I've spent as a volunteer have certainly limited the development of my own skills. However, I can say without any reservation that the volunteer time and effort that I've spent has significantly benefited the student/competitors in our North Dakota shooting sports programs. For the most part, I have been well-fed and rewarded for any sacrifice I've made to the benefit of the North Dakota shooting sports programs.

Sadly, I have seen many volunteers decide that they are not being fed well enough for their efforts. Many of those volunteers who are no longer involved as volunteers in the North Dakota shooting sports are highly skilled. They provided substantial benefit to the North Dakota shooting sports throughout the time that they volunteered as coaches, match directors, and club and Association officers.

Ours is a very small group of volunteers. Some of them you do not even know exist. It is our sincere hope that some of those who have benefited from our efforts will step into our shoes as volunteers who will keep the North Dakota shooting sports program successful in years to come. For example, a volunteer coach or match director is fed very well, when a student/competitor offers to help with the coach's efforts or with the efforts of the match director. Initially, the student/competitor can offer to perform any number of menial tasks that complicate a match director's or coach's volunteer efforts. Later, the student competitor can work up to performing all of the volunteer duties of a coach or match director. Actually, that is the way that a shooting sports volunteer program develops and survives. It is not just about medals and trophies. It is about something much more valuable.

## Concealed Weapons Licenses - New Requirements

### JULY 1, 2011 – NEW REQUIREMENTS:

**ALL APPLICANTS:** A satisfactorily completed application/renewal form must be received by the BCI before the processing time period starts. An application that is incomplete is not considered "satisfactorily completed" and will not be accepted by the BCI. It will be returned to the applicant for correction and submission.

**RENEWAL APPLICANTS:** Timely renewal is the responsibility of the license holder. The BCI does not send out license expiration or renewal reminders. If your license expires during the renewal process you cannot carry concealed until you receive the new license. You must submit a satisfactorily completed renewal form within 90 days of the expiration of your license in order to avoid retesting.

**INVALID FORMS:** Beginning July 1, 2011, BCI will destroy invalid applications. The applicant will receive a notification by mail that the application/renewal was invalid and has been destroyed. The applicant will be required to start the application/renewal process again, including obtaining photographs, fingerprints, etc. as applicable. We apologize for any inconvenience this may cause and encourage applicants to ensure the application is valid before submitting it. An application is INVALID and will be destroyed if:

- It is not the current form. The current form has an issue date of 06/2011. (NOTE: Old application forms being processed by local law enforcement will be accepted by BCI if the law enforcement agency received the application prior to July 1, 2011)
- It is not an original form issued by the BCI.
- The law enforcement official(s) who signed the application is/are not from the applicant's city and/or county of residence.
- Applicant began the renewal process more than 90 days prior to the license expiration.
- Applicant began the renewal process more than 90 days after the license expired.

These are the somewhat less than friendly guidelines that are now being followed by the North Dakota Bureau of Criminal Investigation as they process our applications for concealed carry license or renewal. Clearly, the Bureau of Criminal Investigation recognizes that these guidelines create at least any inconvenience to those who apply for concealed carry licensure.

I am not at all sure what prompted the development and implementation of these guidelines.

I expect that someone in the Bureau of Criminal Investigation was continually inconvenienced by the old process.

Unfortunately, it is reasonably certain that there will be a large number of people who will fail to meet the prompt renewal requirements outlined above. I expect that someone at the Bureau of Criminal Investigation will be continually inconvenienced by the current process.

Those current holders of concealed carry permits who do not begin their renewal process within the time limits outlined will have to retake the test and present a new application. Those new applications will have to be processed by the Bureau of Criminal Investigation personnel with an expenditure of far more effort than would be necessary for simple renewal.

Oddly enough, the period of time from submission of an application to the Bureau of Criminal Investigation for a concealed carry permit until the actual time that permit is issued and back in the hands of the applicant has become very long. I know people who waited over five months from the time they submitted their renewal paperwork to the BCI until they actually received their renewal permit.

New applicants are waiting months, from the time they successfully pass the test and submit their paperwork to the Bureau of Criminal Investigation, for their permits. If any of these applicants have an immediate need for the concealed carry permit, they are very poorly served by this lengthy process.

At this point, I hope that the staff at the Bureau of Criminal Investigation will begin to process new and renewal concealed carry permit applications much more promptly.

As I've said many times before, you cannot drive to your favorite hardware store to purchase a fire extinguisher when your house is on fire. It is far too late at that time to go out and purchase the fire extinguisher that you need to prevent your house from burning down.

If it is going to take months for the Bureau of Criminal Investigation to process a new or renewal concealed carry permit, one or more of our applicants will be far more than inconvenienced.
