Editorially Speaking

I was reading the Virginia Shooting Sports Association Sept/Oct 2003 issue of The Bullet and found a couple of real interesting points in their President's Column. President Steve Canale makes the point that trying to refute the arguments of those who subscribe to the anti gun philosophy point by point are participating in a futile exercise. He suggests that we make every effort to be assertive rather than make any immediate effort to educate. He points out that a typical discussion about gun control lasts only about 7 minutes or less, and that is just not long enough to educate or persuade. By providing an assertive statement, you place the antigunner on the defensive. His example of an assertive statement is "Imagine a place where there are no guns, no drugs, and a cop on every corner. Well in America, there is a place like that, it's called prison, but as everybody knows, prisons are very dangerous places." Clearly, this is a great example that criminals are inherently dangerous, and they will never obey gun laws or drug laws. Laws are obeyed only by the honest law abiding citizens like us, and do not make criminals safe.

He goes on to ask how to rebut the anti-gun argument that gun control laws prevent childhood deaths, but he doesn't provide any suggestion for an effective response. I believe that there are a number of good assertive responses. I would like to read yours. Send me your response in 25 words or preferably less by email, and I will publish the best of those that I receive in our next newsletter. If you have a good assertive statement or response to the many other routine assertions by the gun control groups, send me those in 25 words or less, and I will publish the best of those as well.

Steve reminds his readers that "a fool can ask more questions than a wise man can answer."

In that same issue of The Bullet, there is a press release about the accomplishment by the Arlington Optimist -Acorns Combined Junior Rifle Club at Camp Perry's National Smallbore National Team Championships. Former North Dakota HP Shooter Fires a 495

MSgt Neil Jensen's high power rifle success in recent matches indicates that being assigned duty in the greater Mediterranean/Caspian Sea part of the world for extended periods of time and several tours has not diminished his ability to be competitive with the high power rifle.

Neil recently won the Nevada State High Power Rifle Championship with a 787-23X on the weekend of October 18-19 near Boulder City which, of course, is near Boulder Dam.

What Neil was really "up" about was his shooting the week prior to the Nevada State High Power Championship! The club he is a member of had sponsored a registered HP across the course (500 aggregate) match on October 11-12. His score was 495-23Xs. He was fortunate in one sense that the match was registered because their club calls that match their "monthly open match"!

Neil was shooting an AR-15 type rifle made at Compass Lake Engineering by Frank White that has a 26-inch Krieger barrel. Neil used factory-made 5.56 mm ammo by Black Hills at 200 yards. That ammo has a 75-grain Hornady bullet.

At 300 yards he used his handloads, which were made up from 77-grain Match King bullets; 23 grains of 2495RB powder, and 7.5 Remington primers in an IMI case. More handloads for 600 yards: using the 80-grain Nosler match bullet with 23.5 grains of Accurate Arms 2495 BR powder, using the CCI BR primer loaded .015" off the lands, in the WW case. All bullets were molly-coated.

He said that when he switched from the Remington primer to the CCI primer, his group size became smaller by an inch or two, now believing that it could hold a 4-inch group at 600 yards.

The 495 score should place him in the NRA's "495 Club". I can't say that I know of anyone who is a member of that club and Neil only personally knew two shooters who were members. It will be interesting to learn just how many members that club has.

Neil hopes to be at Camp Perry in 2004. He will, in all likelihood, also be back in one of the Middle East countries for yet another tour, before Perry begins. I think this will be Neil's eight or ninth tour in the greater Mediterranean /Caspian Sea area.

High Power Rifle results

September 15, 2003

It is safe to say that more records were set in one competitive event this past weekend than in all other events combined. You see, there was a new game in town thanks to the Bismarck/Mandan Rifle and Pistol Association. That new game was the first Regional Long Range High Power Rifle Match ever fired in North Dakota; so virtually every shot fired set a new record. From the enthusiasm shown by all competitors, they will be back again to try to break those records.

Shooters from Montana, North Dakota, and Minnesota fired five individual twenty-shot matches over the two days at a distance of 1,000 yards to compete for the gold. Brisk gusty winds and intermittent sprinkles on Saturday, and shifty breezes and changing light conditions on Sunday added their dimensions to make for very challenging conditions.

Tom Thompson of Bismarck shot a 7mm Remington Magnum to put together an aggregate score of 963-38x for the five matches to win the Gold Medal. Mr. Thompson also fired the high score for an individual match as he dropped only one point on his last shot in Match Four for a near perfect 199-13x. Tom Reiten of Grand Forks took home the Silver Medal as he fired a score of 955-23x with his 6.5 X 284. Neil Adams of Billings, Montana earned the Bronze Medal with a score of 947-19x. Neil also fired the 6.5 X 284 cartridge. First in the Master Class was William O'Connell of Grand Forks with 929-19x; and the winner of the combined Expert and Sharpshooter Classes with a score of 855-11x was Anthony Kozojed of Thief River Falls, Minnesota.

Marc McDonnell of Spring Lake Park, Minnesota used a .300 Ultra-Mag to win the "F" Class, (any rifle, any sight, any reasonable support), with a score of 945-37x.

All competitors agreed that in spite of the fact that the team match scheduled for Saturday afternoon had to be canceled due to increasing winds blowing sand into everyone's rifle actions, the challenge of 1,000 yard shooting was worth coming back for next year.

Bob Foth Air Rifle Clinic

Olympic Silver Medalist and three time U.S. Olympic Rifle Team member **Bob Foth** held an Air Rifle Clinic on **October 10-12** in the Fargo Regional Training Center in Fargo. Those of you who had the good fortune to attend know what I mean when I say that this was a great experience for coaches and shooters of all ages.

Bob is a very well spoken man, and he delivered organized coaching comments and suggestions clearly. Bob is committed to helping all of our shooters to meet and exceed their goals. This clinic was a rare chance to be coached one-on-one by one of the most qualified coaches in the country. Bob covered all aspects of shooting including not only the positions and mechanics of shooting, but also things like mental preparation, the shooter's diary, setting and reaching goals, as well as equipment and how to use it properly.

The very useful and high quality handout materials were provided by the Civilian Marksmanship Program. This clinic consisted of livefire as well as classroom instruction from 7:00pm to after 9:30pm Friday. Saturday's class went from 8:30am until after 5:00pm. Lunch on Saturday was ably and graciously provided by Char Pueppke. Char also provided delicious snacks (water, banana bread, cookies. etc.)

We met again Sunday at 8:30am until about 1:00pm. Sunday's final hour or so consisted of a Finals Match for all of the juniors followed by a Guts Match. Bob then gave each junior/coach pair the opportunity to set down their short term and long term goals for their shooting and to plan out the steps they will follow in their path to reach those goals.

Thanks to Eric and Char Pueppke and to James Ladwig for their efforts to organize and make this event a success. Most of all, thanks to Bob Foth and to Gary Anderson at the Civilian Marksmanship Program. I have not attended a better shooting clinic, and believe that everyone who participated learned something that will improve their skill as a shooter or coach. I believe that this clinic experience provided a very solid and positive foundation for the future of competitive shooting in North Dakota.
